Sandwich Board Signs must be placed at the back of curb, against the building, or in the bump-outs, but shall not impede the use of the on-street parking stalls or create vision obstructions at intersections that constitute a safety concern. No obscene or questionable language or images shall be placed on the Sandwich Board Sign. The sign can only be on display during times that the business is open to the public.  These Sandwich Boards were purchased from the Village and are intended to stay with the property and the original property owner(s) to whom they were initially distributed; otherwise this permit is void. If, for any reason a replacement of a Sandwich Board Sign is needed, a new one can be purchased from the Village.  The Village reserves the right and authority to cancel any Street Occupancy Permit and		
Sandwich Board Sign Use Agreement based on failure of the permit holder to follow the rules and requirements established in this policy and/or to amend or eliminate this program and rules at its sole discretion.
